

PAYMENT OPTIONS

- In person at the Town Hall Finance Dept.
Cash, cheque or interac accepted
- Mail cheques
(Post dated cheques accepted)

If you are making payments online, please insure that you are paying the correct account (Property Taxes not Utilities) and using the correct account number

Misallocated payments will only be corrected on a one-time basis. Subsequent payment adjustments will be subject to a \$25 admin fee

PRE-AUTHORIZED PAYMENT (2022)

Sign up for the Town's Property Tax Pre-Authorized (Monthly) Payment Plan

- Your 2021 taxes must be paid in full by 4:00pm on July 2, 2021 to take part in this plan for 2022
- If you are already on the plan, you do not need to reapply for 2022
- Pay your 2022 taxes in 10 equal monthly payments
- Payments run monthly from August 2021 to May 2022 on the 10th of each month

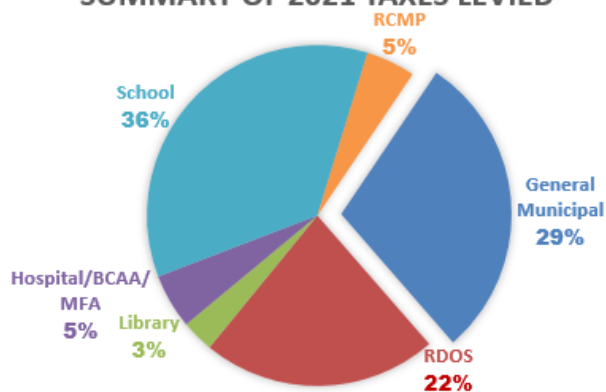

Your property tax notice contains taxes collected for all the services provided by the Town and also taxes collected for other government agencies

Your 2021 Taxes

In 2021 the municipal tax levy collected by the Town of Oliver on the average residential property will be \$2,403, allocated to the general municipal services as follows:

Penalty Dates

- 5% will be applied to the balance of current taxes unpaid after **July 2, 2021**
- a further 5% will be applied to the balance of current taxes unpaid after **August 31, 2021**

Home Owner Grant

NEW

Home Owners Grants are no longer accepted at Town Hall or on the Town's website.

In 2021, the home owner grant application process changed, but program details and eligibility requirements have **not** changed.

Residents in municipalities no longer apply for the home owner grant through their municipal office. Everyone now applies directly to the province using a new online system that's easy to use and will process applications faster.

The home owner grant is a provincial program that helps reduce the amount of residential property tax you pay. You must claim your home owner grant for the current year, even if you successfully claimed it in the prior year.

You also must claim the grant even if your taxes are paid by your mortgage company or you are deferring your payment.
